## **HOA Dues**

HOA dues are currently \$250 per year, with a due date of January 31. Invoices will be mailed the end of December. Late or missing payments make it difficult to do so. Please remit your payment so it is received on or before the due date. As a reminder, we do not accept electronic payments.

## **Mailbox Break Ins**

We had 3 mailboxes broken into on Nassau in April and another one on 47th Avenue in August. All were reported to the Tacoma Police Department and the United States Postal Inspection Service. These mailboxes were replaced at HOA expense at a cost of \$12,500. While a special assessment was not required to cover these costs, the balance in our operating account was severely impacted. The good news is there are only two mailboxes remaining in the development that are not the latest design and lack the most recent security features. We will be replacing those boxes as well.

## How to Prevent Crime In Our Neighborhood

There are many things you can do to make our neighborhood safer and deter criminals. Here are some of the top tips from the National Crime Prevention Council:

- Lock your doors and windows, even when away for a short period of time.
- Use deadbolts and security systems with an alarm.
- Don't leave spare keys under doormats, in flower pots or other obvious places.
- Light up your home at night.
- Install a "smart" doorbell.
- Have your neighbors' contact information on hand. Let them know if you notice things like open doors, garage doors, windows, or anything else that looks unusual.





## **Auto Theft Prevention**

As you may have heard, there was a recent auto theft in our neighborhood. According to the National Insurance Crime Bureau, Washington is ranked fourth in the nation for auto theft. Don't be a statistic. Here are some things you can do to make your vehicle a harder target for thieves::



**Don't Be a "Puffer:"** Leaving your car running and unattended in the driveway to warm up is an invitation to thieves. It's not only risky, but illegal in Washington state. Thieves often patrol neighborhoods looking for the signs of exhaust coming from idling cars.

**Park Inside a Locked Garage:** Use your garage to park your car rather than for storage. A locked garage can deter thieves from breaking into or stealing your car or parts like catalytic converters, tires and batteries.

**Take Keys and Fobs Out of Your Car and Lock Up:** Whether your car has a keyed or keyless ignition, leaving your keys or fob in the car is a sure way to get it stolen. Keyless ignitions make it easier for drivers to forget their fobs in the car, so always double check to make sure you have it when leaving your vehicle.

**Clean Out Your Car:** Anything left in your car can tempt thieves to break in and see what they can find. Even items that may not be worth much to you, like coats and spare change, can attract unwanted attention. A thief who breaks in to get those items may steal your car as well.

**Consider Taking Your Opener, Registration and Proof of Insurance Out of Your Car:** These items can give thieves access to your personal information and home. The law requires you have the documents when driving the vehicle, not that you leave them in your car. You can treat them like your driver's license and have them with you when driving, but not stored in the car.

## Sharing the Road with School Buses, Pedestrians and Bicyclists



Here are some reminders and tips for driving safely through school zones

**Red Flashing Lights (RCW 46.61.370):** In Washington State, drivers <u>must stop</u> when behind a bus traveling in the same direction, regardless of the number of lanes and when on a two-lane road heading in the opposite direction of the bus. Drivers do not need to stop on a road with three or more lanes when heading in

the opposite direction of the bus or on a divided highway headed in the opposite direction of the bus.

Stick to 20 mph or Less in School Zones: You can keep kids safe and avoid a ticket by going the speed limit in school zones. No matter what the time of day, remember "twenty is plenty" when driving through school zones. Pedestrians hit by a vehicle driving 20 mph or less stand a 90-95 percent chance of survival.

**Pedestrians and Cyclists Have the Right of Way at Crosswalks and Intersections:** You must yield to them and give them enough space to maneuver.
